NSE Indices plans to launch its own ESG Scores / Ratings in the near future and once launched, use the same for its ESG indices. In the interim, starting from the index review effective date (December 29, 2023), the ESG Scores / Ratings for the Nifty ESG indices shall be sourced from Stakeholders Empowerment Services (SES) instead of Morningstar Sustainalytics. In order to align the index methodology with the ESG Scores / Ratings of SES, it has been decided to make the following changes to the methodology of the Nifty ESG indices.

Accordingly, the above replacements have been identified in the Nifty100 ESG, Nifty100 Enhanced ESG and Nifty100 ESG Sector Leaders indices based on ESG Scores / Ratings sourced from SES.

1) Revision in methodology of the Nifty100 ESG index and Nifty100 Enhanced ESG index
